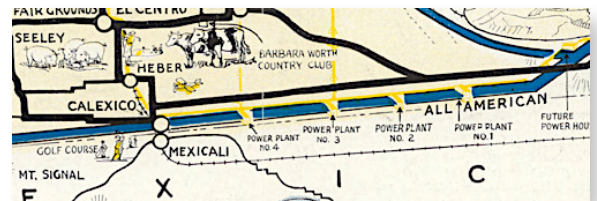

The twin cities of Calexico (Imperial County, California) and Mexicali (Baja California, Mexico) straddle the US/Mexico border. So it's not surprising that when Prohibition began in the United States (1920), drinking establishments across the border experienced a burst of

popularity. One such club was the A.B. & W. Club (The Owl) in Mexicali. The club was a combination saloon, dining room, and, it is rumored, brothel and gambling casino.

**JANUARY MEETING RECAP**

**David McCarthy** and **Don Kagin** have recently published the definitive guide to private and pioneer gold, *America's Golden Era: Private & Pioneer Gold Coins 1768—1862*. Don explained part of the fascination in pioneer gold coins: every one is different. He talked about his early family interests in pioneer gold. He did a PhD dissertation on the subject and published a book on it in 1981, which remains a standard reference today.

After forty years there were many new discoveries and many corrections needed. David joined Kagin's in 2003 and helped with diagnostic studies to make many of the discoveries. This all prompted them to jointly write a new book. It's not a second edition of the first book, but rather a new work based on chronological—not geographical—order.

It was shortened to have broader appeal, yet it includes population reports and many minting details. *(continues...)*
